

## **Housing Allocation Policy Consultation**

## Introduction

On 1 April 2023, all eight councils across North Yorkshire joined together to become one unitary authority, North Yorkshire Council.

At present, North Yorkshire Council operates two schemes for allocating social housing:

- ~ North Yorkshire Home Choice which covers all localities except for Harrogate
- ~ A standalone allocation scheme covering the former Harrogate Borough Council area.

The council must have a single housing allocations policy and scheme covering all of North Yorkshire in place by 1 April 2025.

The North Yorkshire Home Choice allocations scheme sets out how this is achieved via a Choice Based Lettings (CBL) scheme. This scheme will apply to all households seeking to be rehoused across North Yorkshire and existing social housing tenants wishing to transfer.

The Allocations Policy Review will consider a number of areas that need to be revised or potentially introduced.
